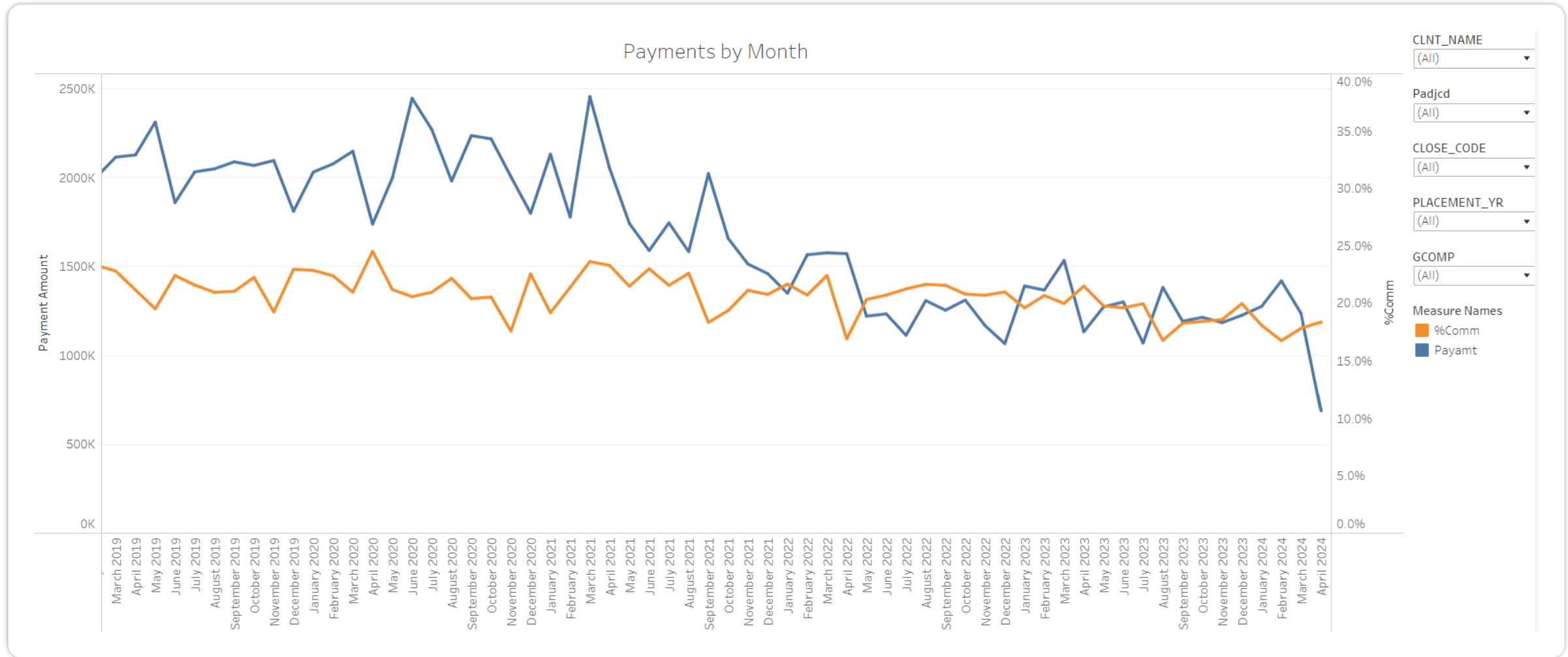

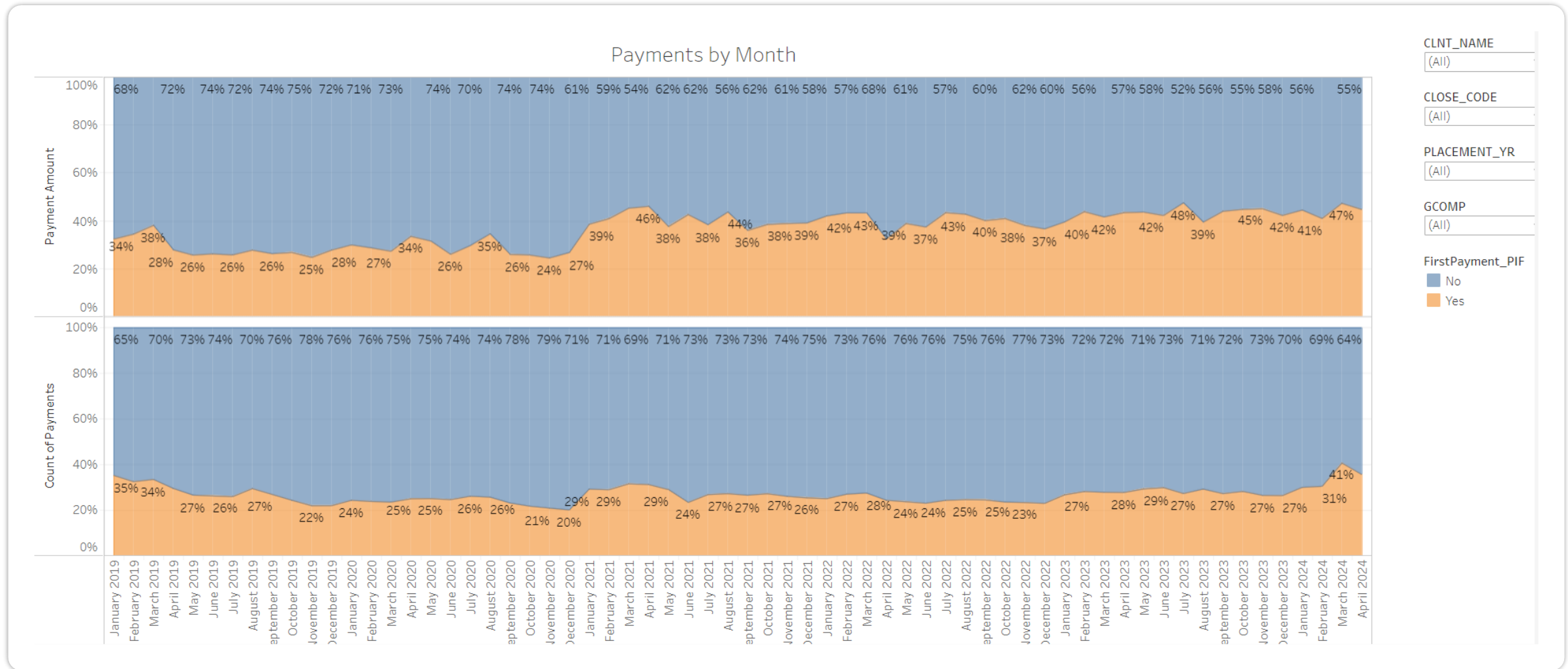
Payment & Commission

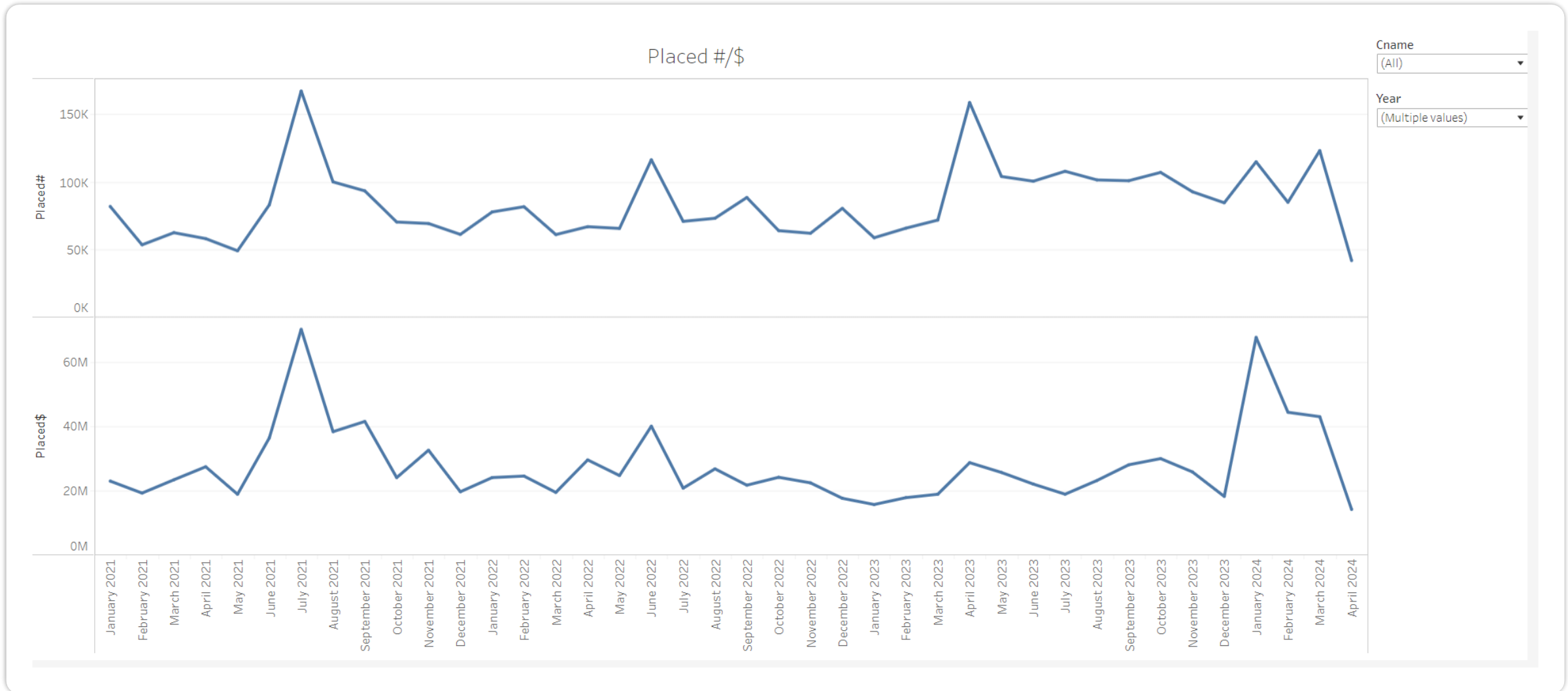

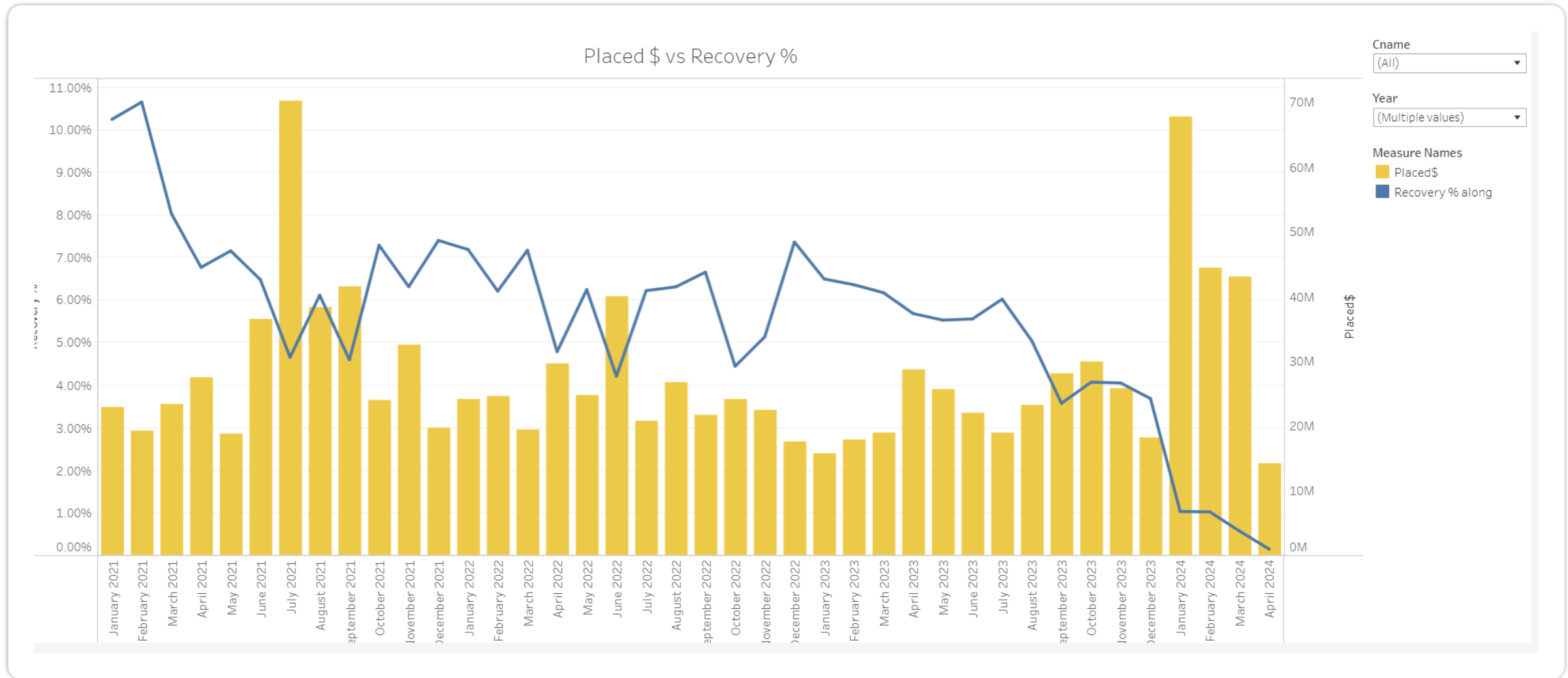

Placed \$ vs Placed Account #s by month



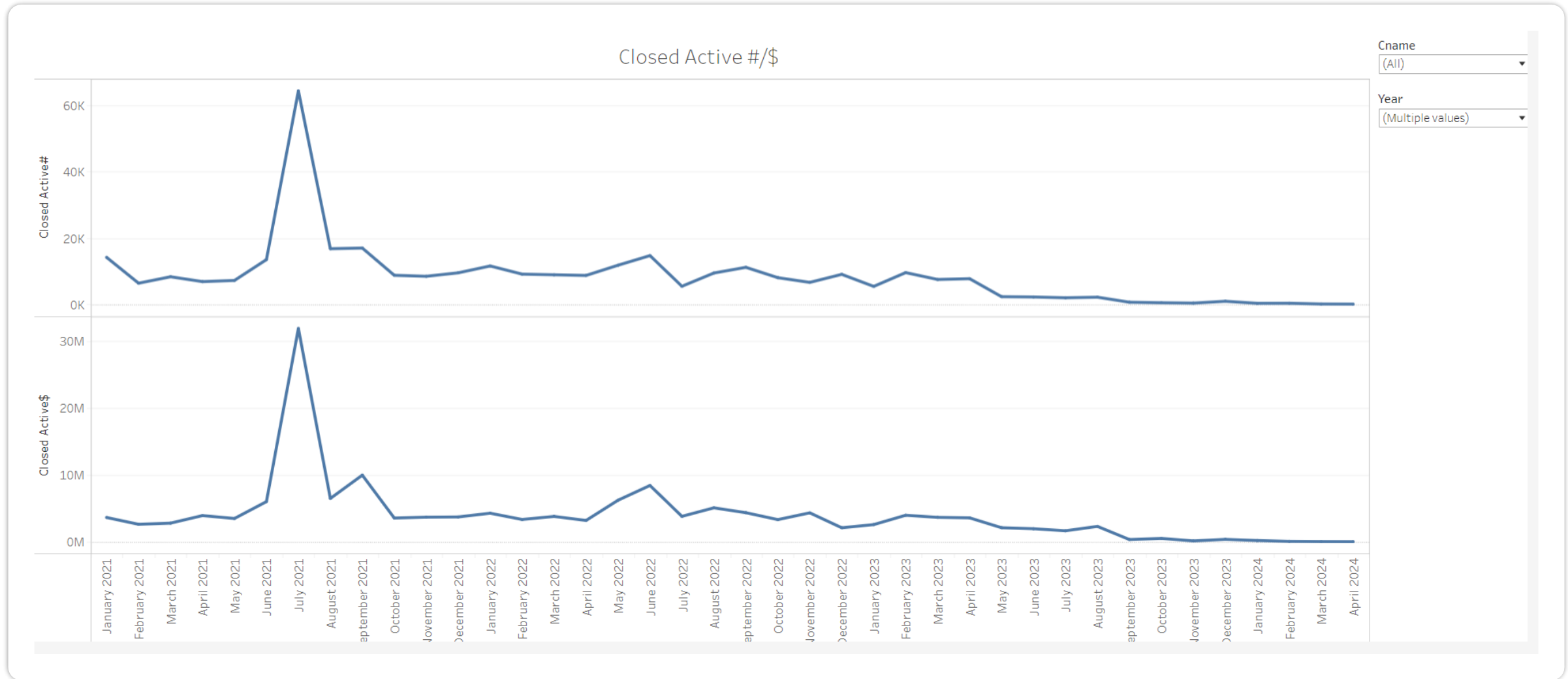
Placement Recovery

Placed \$ vs Recovery % by month



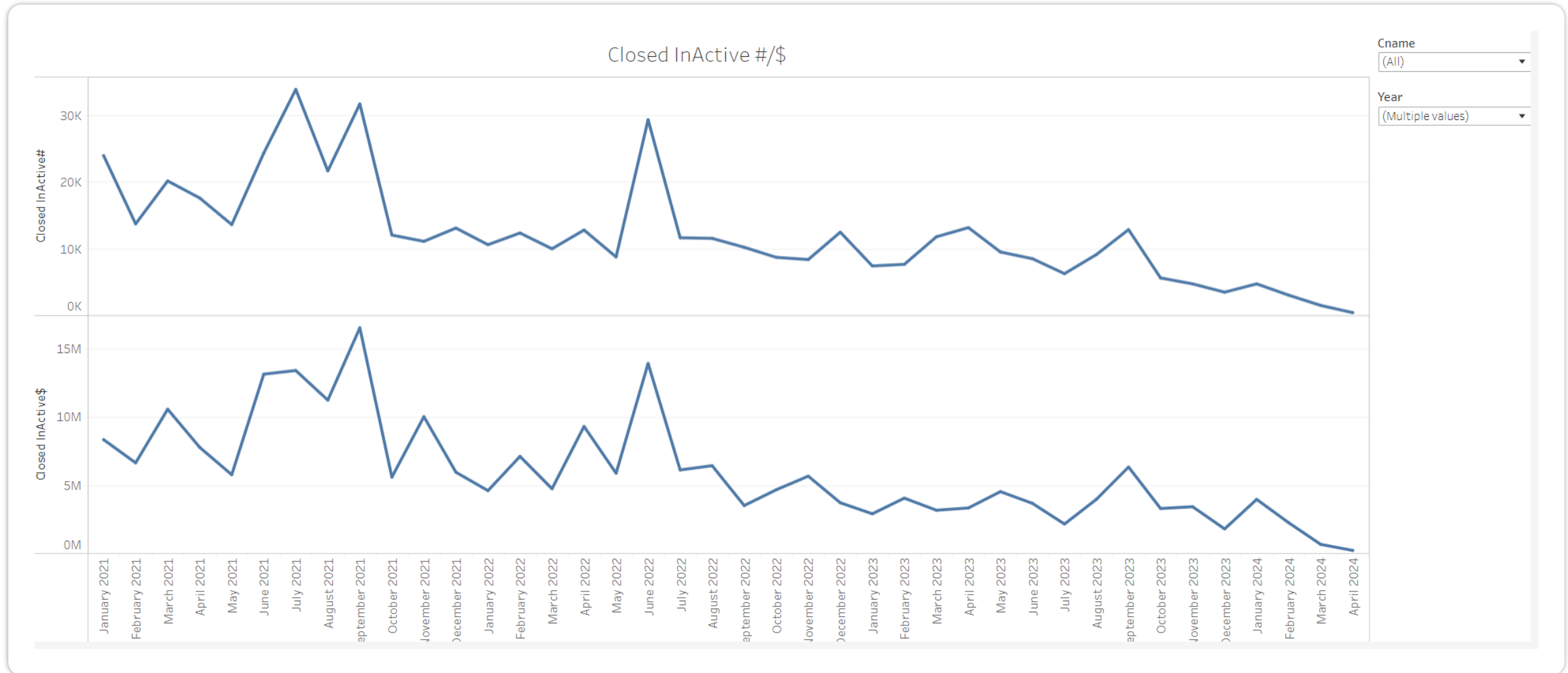
Closed Active Accounts

Placed \$ vs Placed Account #s for Closed Active accounts by month



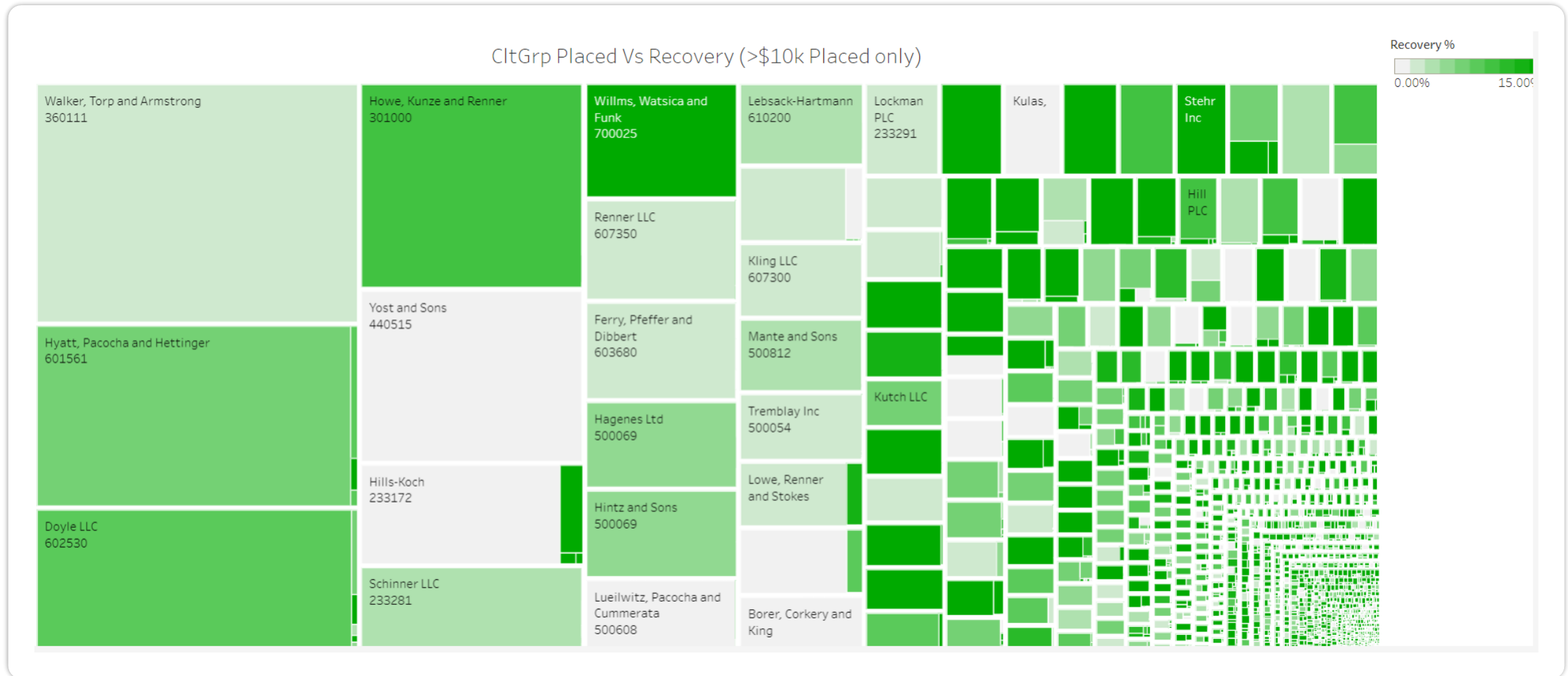
Closed InActive Accounts

Placed \$ vs Placed Account #s for Closed InActive accounts by month



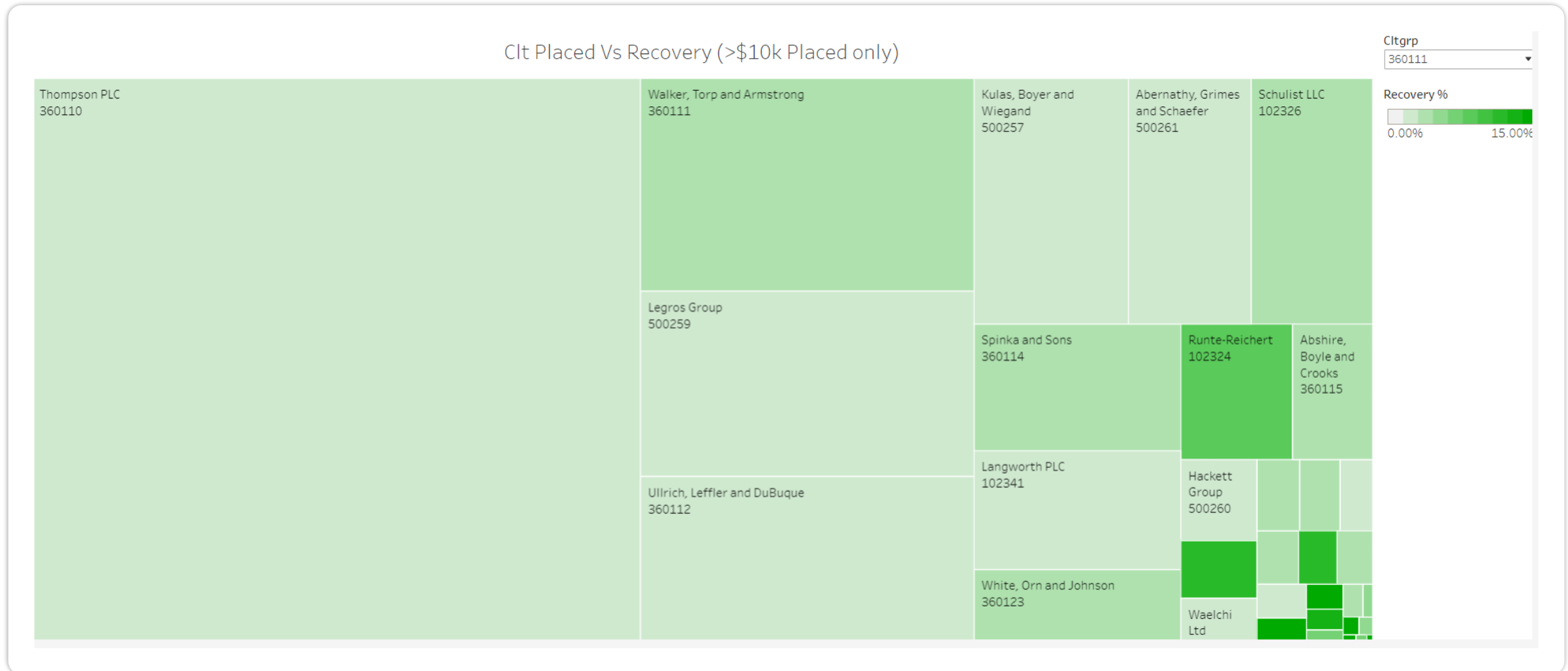
Client Group Productivity

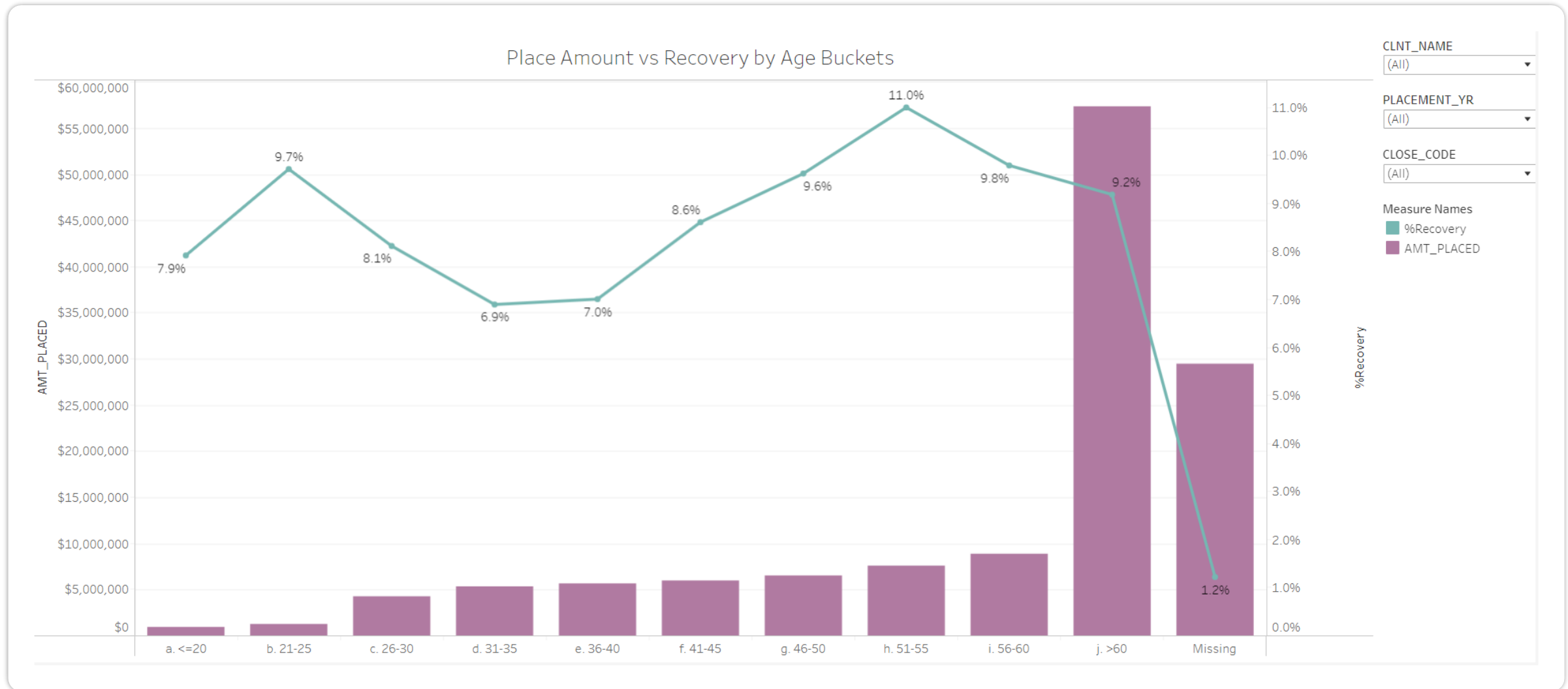

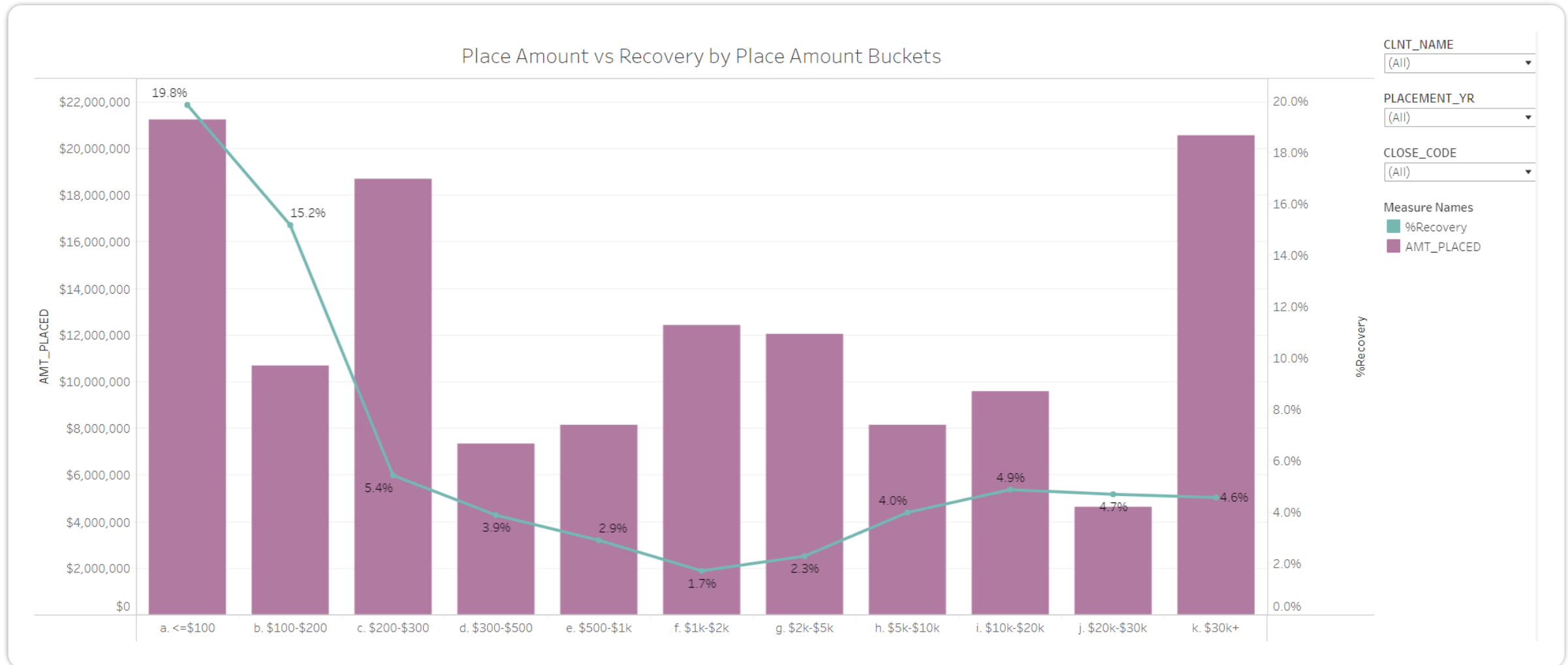
KPI Distribution by Age

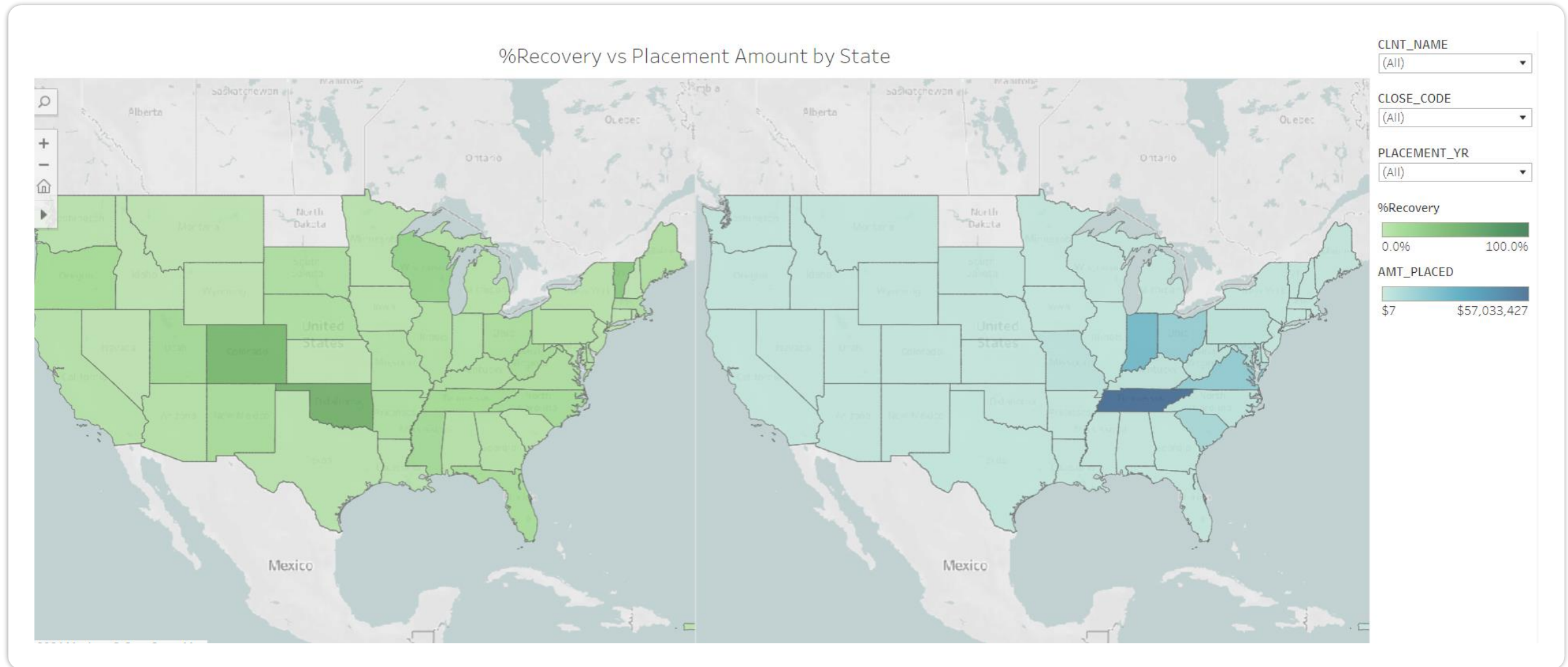

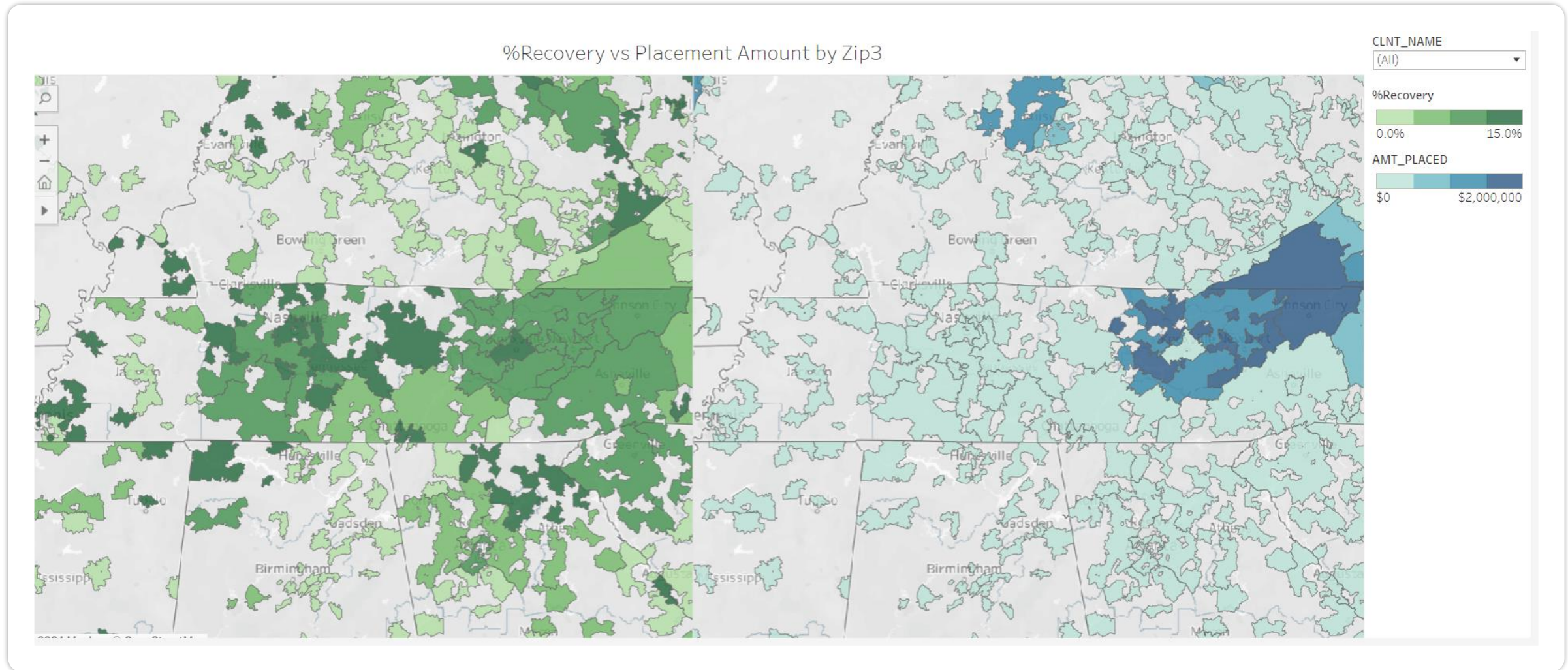
Distribution by State

Geographical heat map of \$placed amount and %recovery at a state level



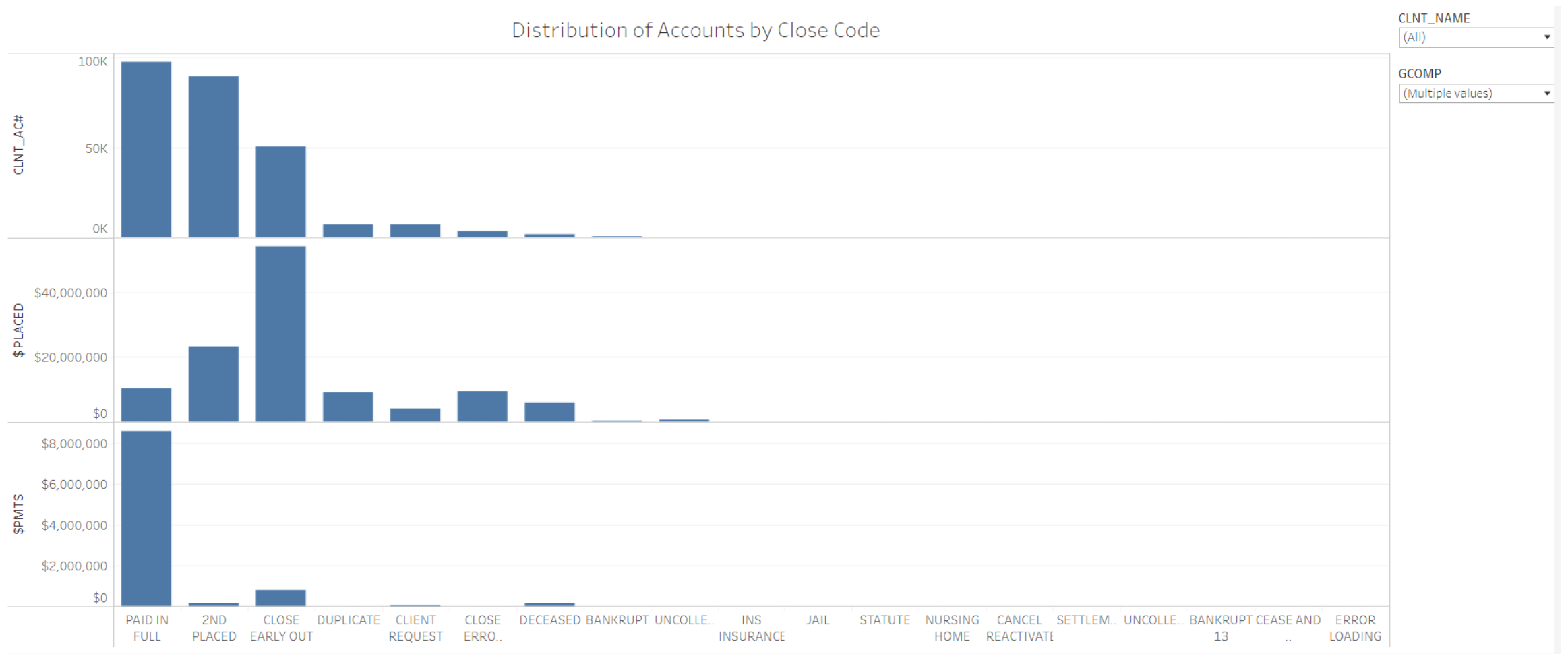
Localized Geo Distribution at Zip3 level

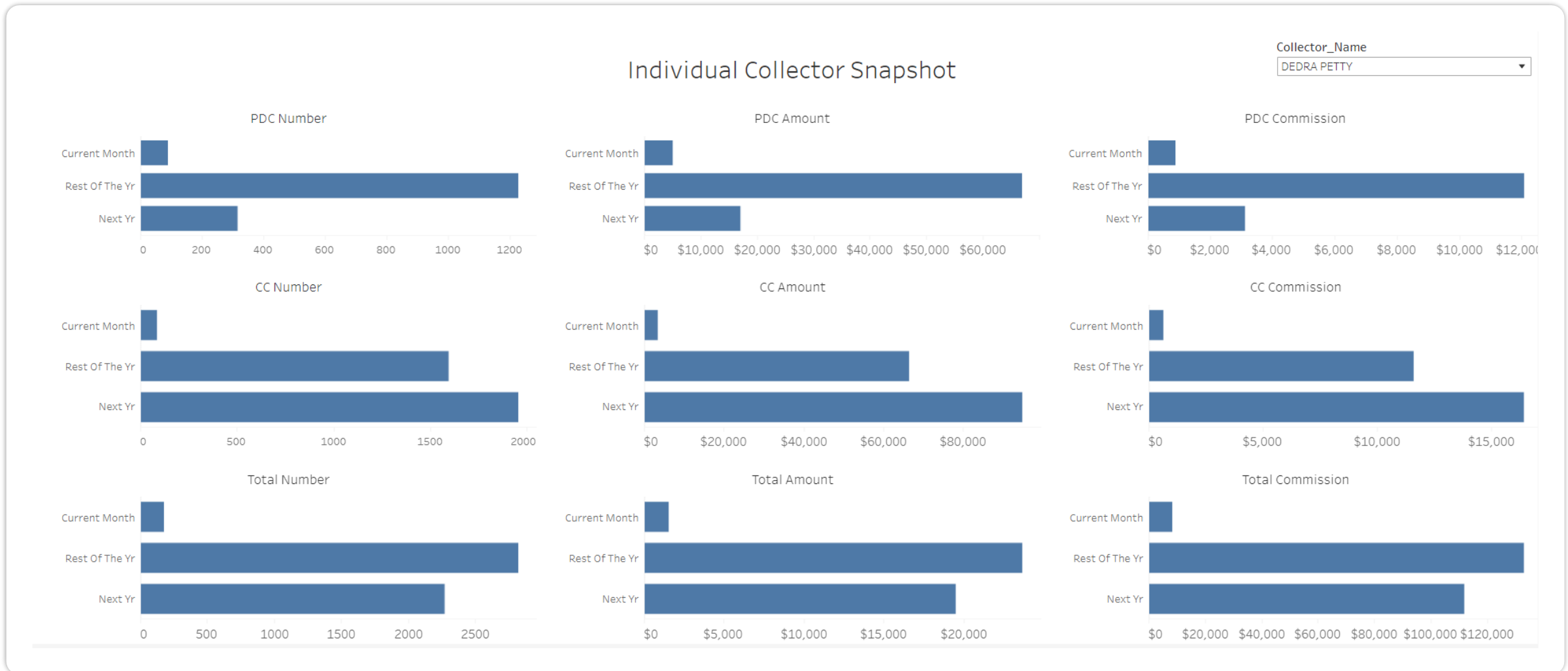

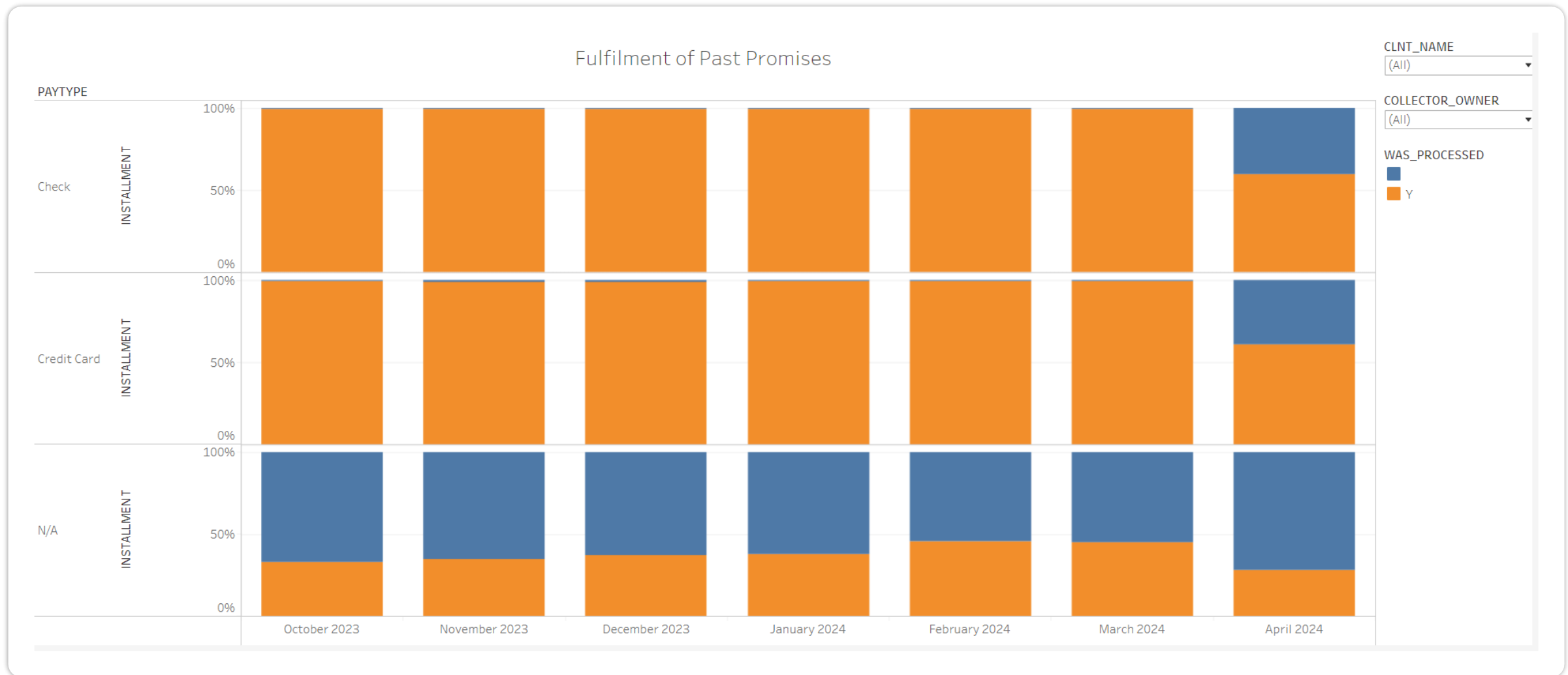

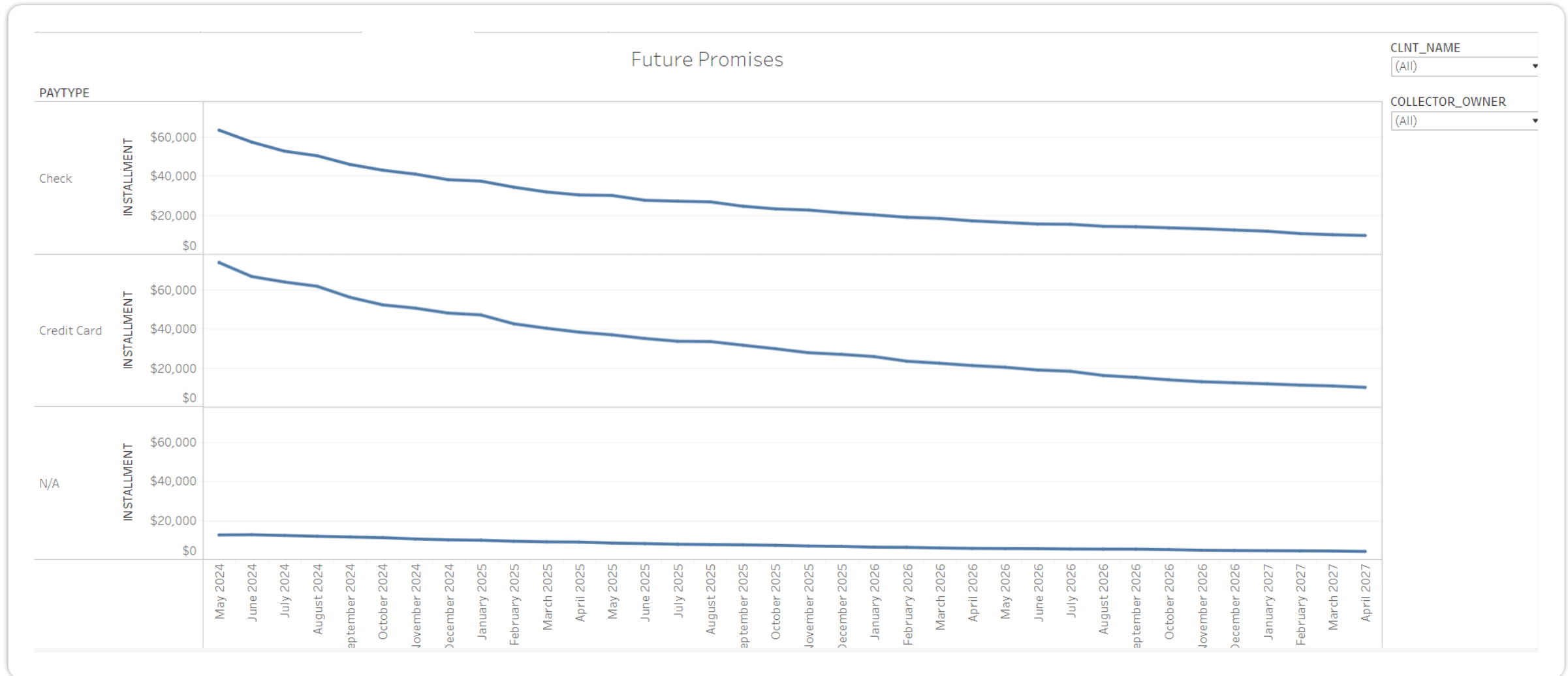
Past Promise Fulfilment

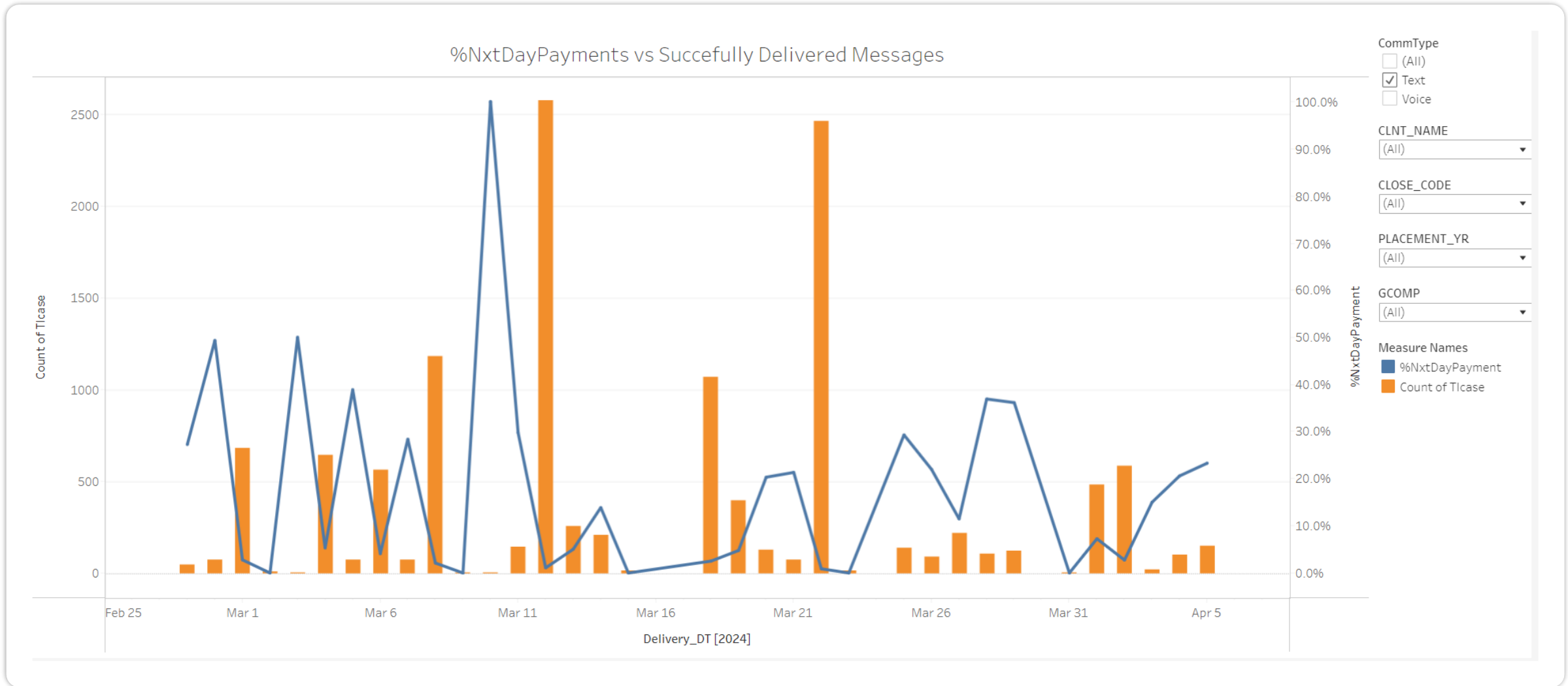

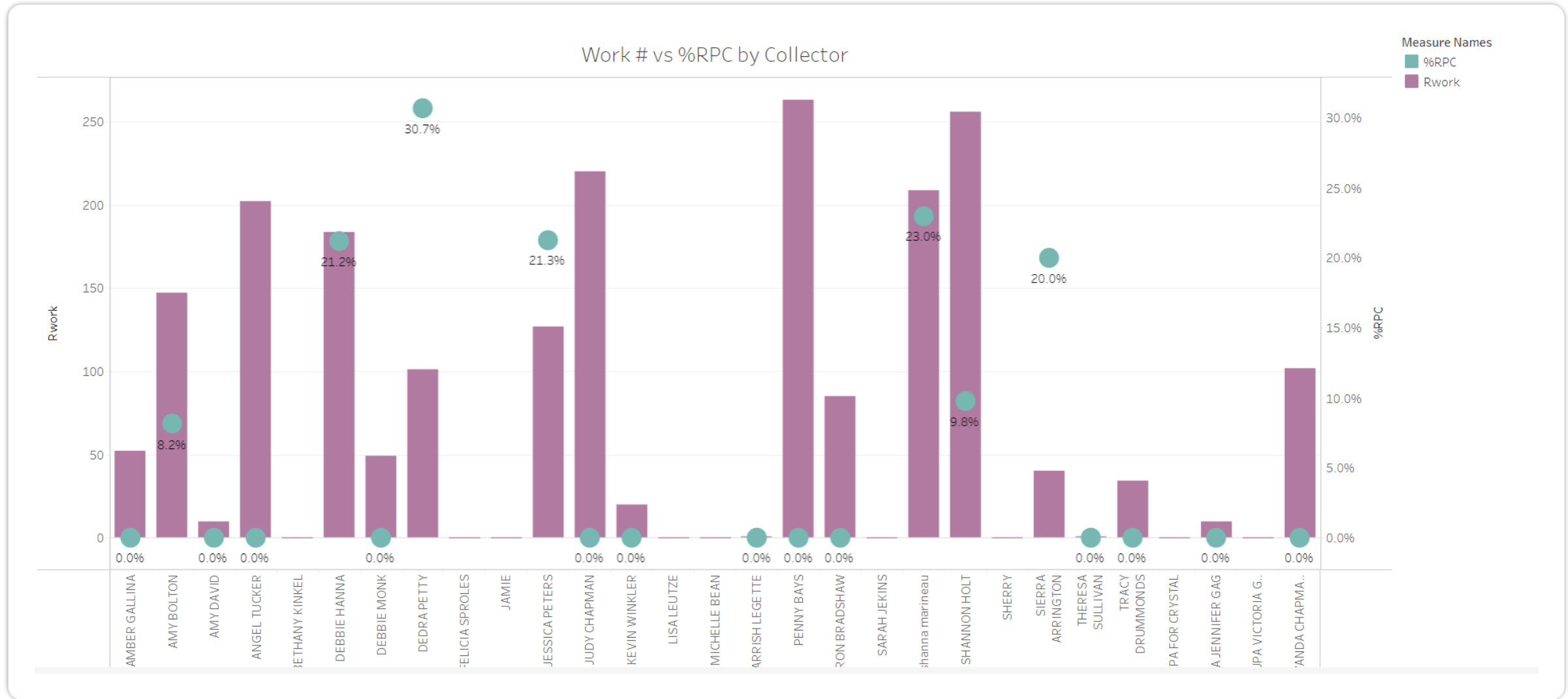
